Failure to promptly provide requested documentation, or false claims of experience are grounds to deny the application, or suspend or revoke an applicant's current license.

Examination

After your application is accepted for processing and education and experience requirements are satisfied, you will be notified of eligibility to sit for the examination. License examinations are administered by a national testing service contracted by TREC. The exam eligibility notification will have instructions for contacting the exam administrator and obtaining a copy of the Candidate Handbook. The Candidate Handbook contains information about the examination, study material, and instructions for making an exam reservation.
