APPLICATION FOR EASEMENT OR RIGHT-OF-WAY AGENT REGISTRATION BY AN INDIVIDUAL

(PLEASE READ ALL INFORMATION CAREFULLY)

To be eligible to file an application for an Easement or Right-of-Way Agent registration, an individual must be a citizen of the United States or a lawfully admitted alien and eighteen (18) years of age or older. A Deferred Action for Childhood Arrivals (DACA) recipient does not qualify as a lawfully admitted alien.

Each registration is required by law to have fingerprints on file with the Department of Public Safety (DPS) for TREC. Fingerprints on file for other agencies will not be accepted. The registration will issue once all requirements are met and TREC receives confirmation from DPS that the applicant's fingerprints are on file. For additional information regarding fingerprinting requirements, including how to schedule an appointment, please visit www.trec.texas.gov/fingerprints-requirements.

ALL REQUIRED FEES MUST BE SUBMITTED WITH THE APPLICATION. AN APPLICATION SUBMITTED WITHOUT THE APPROPRIATE FEES WILL BE REJECTED AND RETURNED. All fees should be paid by **CASHIERS CHECK, PERSONAL CHECK OR MONEY ORDER** payable to the Texas Real Estate Commission. DO NOT PAY WITH CASH.
