IMPORTANT INFORMATION - PLEASE READ CAREFULLY

This application must be filed through the sponsorship of a Texas Professional Inspector who is qualified to sponsor applicants and who currently holds an active license. Both the applicant and the sponsoring Professional Inspector must sign this application. All correspondence regarding this application will be copied to the sponsoring inspector. The application is not transferable. A sponsoring Professional Inspector cannot be changed during the processing of an application. If an applicant desires a different sponsoring Professional Inspector, a new application and fees must be filed with the Commission.

- To apply, you must be a citizen of the United States or a lawfully admitted alien and eighteen (18) years of age or older.
- You must have fingerprints on file with the Department of Public Safety (DPS) for TREC or TALCB to satisfy the statutory requirement for honesty, trustworthiness and integrity. **Fingerprints on file for other agencies will not be accepted**. For additional information on fingerprinting requirements, including how scheduling an appointment, please visit www.trec. texas.gov/fingerprint-requirements.
- Submit copies of course completion certificates and experience requirements. DO NOT SUBMIT ORIGINALS.
- After your application is accepted for processing and education and experience requirements are satisfied, you will be
 notified of eligibility to sit for the examination. License examinations are administered by a national testing service
 contracted by TREC. The exam eligibility notification will have instructions for contacting the exam administrator and
 obtaining a copy of the Candidate Handbook. The Candidate Handbook contains information about the examination, study
 material, and instructions for making an exam reservation.
- After all requirements have been met including passing the examination, you must submit **proof of professional liability insurance**, **or any other insurance** that provides coverage for violations of Texas Occupations Code, Chapter 1102, Subchapter G (\$100,000 per occurrence), on the TREC Certificate of Insurance or Proof of Financial Responsibility Form.
- All requirements for a license must be met within one year of the application filing date, or the application expires.
