IMPORTANT INFORMATION - PLEASE READ CAREFULLY

- To apply, you must be a citizen of the United States or a lawfully admitted alien and eighteen (18) years of age or older.
- You must have fingerprints on file with the Department of Public Safety (DPS) for TREC or TALCB to satisfy the statutory requirement for honesty, trustworthiness and integrity. **Fingerprints on file for other agencies will not be accepted**. For additional information on fingerprinting requirements, including scheduling an appointment, please visit www.trec.texas. gov/fingerprint-requirements.
- Submit copies of course completion certificates and experience requirements. DO NOT SUBMIT ORIGINALS.
- After your application is accepted for processing and education and experience requirements are satisfied, you will be
 notified of eligibility to sit for the examination. License examinations are administered by a national testing service
 contracted by TREC. The exam eligibility notification will have instructions for contacting the exam administrator and
 obtaining a copy of the Candidate Handbook. The Candidate Handbook contains information about the examination, study
 material, and instructions for making an exam reservation.
- After all requirements have been met including passing the examination, you must submit **proof of professional liability insurance**, **or any other insurance** that provides coverage for violations of Texas Occupations Code, Chapter 1102, Subchapter G (\$100,000 per occurrence), on the TREC Certificate of Insurance or Proof of Financial Responsibility Form.
- All requirements for a license must be met within one year of the application filing date, or the application expires.
