- ALL FEES LISTED ABOVE ARE NONREFUNDABLE AND MUST BE SUBMITTED WITH THE APPLICATION. AN APPLICATION SUBMITTED WITHOUT THE APPROPRIATE FEES WILL BE REJECTED AND RETURNED. All fees should be paid by a single CASHIERS CHECK, PERSONAL CHECK OR MONEY ORDER payable to TREC. DO NOT PAY WITH CASH. You can avoid the \$20 paper filing fee if you renew online at www.trec.texas.gov.
- If a broker license expires or is placed on inactive status, all sales agents sponsored by the broker will be placed on inactive status. This includes sales agents sponsored by a business entity broker whose designated broker's license expires or is placed on inactive status.
- NOTE: Under State Law, TREC cannot renew your license if you have defaulted on a student loan guaranteed by the Texas Guaranteed Student Loan Corporation (TG) unless you have entered into a repayment agreement with TG. Your renewal application will be rejected if we receive information from TG that you have defaulted on a student loan. YOU MUST CONTACT TG BEFORE FILING THIS APPLICATION IF YOU HAVE DEFAULTED ON A STUDENT LOAN. TG can be contacted at: P.O. Box 83100, Round Rock, TX 78683-3100 or 1-800-252-9743.

#### To Renew ACTIVE

- License holders must complete 18 hours of acceptable Continuing Education (CE) which must include 4 hours in Legal Update I, 4 hours in Legal Update II, and 10 hours in CE electives. An individual broker or designated broker of a business entity who sponsors agents, or a license holder who is a delegated supervisor of one or more license holders for 6 months or more during the current license term must complete 6 hours in the TREC Broker Responsibility course, 4 hours in Legal Update I, 4 hours in Legal Update II, and 4 hours in CE electives. A list of TREC approved CE providers can be found at the TREC website at www.trec.texas.gov.
- CE hours cannot be carried over from one renewal term to another.
- If TREC records do not reflect completion of CE requirements at the time the renewal application is submitted, the license holder must pay a \$200 CE Deferral Fee, or renew in INACTIVE status. Payment of the CE Deferral Fee allows the license holder to continue to be active in real estate activities, and allows an additional 60 days from the expiration date of the license to complete CE requirements. Failure to complete the required CE within 60 days of the previous expiration date of the license will result in the license being placed on INACTIVE status.
- Sales agents who submit a late renewal for must also submit Sales Agent Sponsorship Form-3.

If the license expires, all required CE hours must be completed and all applicable late renewal and education fees must be paid before the license can be renewed in ACTIVE status.

#### For an INACTIVE renewal

A license holder may file a renewal application and renew a license in inactive status without submitting CE. A license holder cannot engage in real estate brokerage activity with an inactive license.

#### Sales Agent Apprentice Education (SAE) Renewals (Active and Inactive)

A sales agent renewing for the first time must have a total of 270 qualifying real estate course hours, 4 hours of TREC's Legal Update I, and 4 hours of TREC's Legal Update II posted to their license records prior to submitting a renewal.
